## **RESOLUTION 24-026**

# A RESOLUTION OF THE SANIBEL FIRE AND RESCUE DISTRICT BOARD OF COMMISSIONERS ADOPTING THE BUDGET FOR FISCAL YEAR 2024-2025

WHEREAS, the Sanibel Fire and Rescue District (the "District") is an independent special district duly organized and existing under the laws of the State of Florida; and

WHEREAS, the Board of Commissioners of the Sanibel Fire and Rescue District (the "Board") is authorized, pursuant to Section 189.016 and Chapter 200, Florida Statutes, to adopt an annual budget for the District; and

WHEREAS, the total estimated revenues and appropriations for fiscal year 2024-2025 are \$27,582,065, including revenues generated from ad valorem taxes, fees, and other sources; and

WHEREAS, the Board has prepared a proposed budget for fiscal year 2024-2025 and held all required public hearings in accordance with Section 200.065, Florida Statutes, to consider and approve the final budget; and

WHEREAS, the Board has complied with all applicable notice and procedural requirements in the preparation and adoption of the fiscal year 2024-2025 budget.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE SANIBEL FIRE AND RESCUE DISTRICT THAT:

### 1. Adoption of the Fiscal Year 2024-2025 Budget

The Board of Commissioners hereby adopts the budget for fiscal year 2024-2025 with a total amount of \$27,582,065, which includes all estimated revenues and expenditures necessary for the operation of the District.

### 2. Budget Amendment Authority

The Board reserves the right to amend the budget as necessary during the fiscal year in accordance with Section 189.016, Florida Statutes.

#### 3. Compliance with Florida Statutes

The District has met all statutory requirements for the adoption of the budget, including but not limited to the notice and public hearing requirements as set forth in Section 200.065, Florida Statutes.

#### 4. Effective Date

This Resolution shall take effect immediately upon its adoption.
